



## 1 INSTRUCTIONS

Please read these instructions before completing this section. Failure to complete will delay your account being opened.

Regulations based on the OECD Common Reporting Standard ('CRS') require Ramsey Crookall to collect and report certain information about an account holder's tax residence. Each jurisdiction has its own rules for defining tax residence. In general, tax residence is the country in which you live. Special circumstances (such as studying abroad, working overseas, or extended travel) may cause you to be resident elsewhere or resident in more than one country at the same time (dual residency). The country/countries in which you pay income tax are likely to be your country/countries of tax residence. If your tax residence is located outside of the Isle of Man, we may be legally obliged to pass on the information in this form and other financial information with respect to your accounts to the Isle of Man Tax Office.

The information you provide us with will remain valid unless there is a change in circumstances relating to the account holder's tax status or other mandatory fields included on this form. You must notify us if there is a change in circumstances that makes this form incorrect or incomplete and provide an updated self-certification.

Please complete if you are an individual or joint account holder. For multiple account holders please print additional copies of this page, as we require this to be completed by each account holder.

If you are a US person under US Internal Revenue Service ('IRS') regulations, you may also need to fill in an IRS W-9 form.
